


In February 2021 there were still 9.5 million fewer payroll jobs than in February 2020.

#### Job Deficit Still Nearly 10 Million After February Gains


Change in nonfarm payroll employment since February 2020, in millions





### Federal Budget Outlook FY 2021-2022

- Early \$1.5 trillion "skinny budget" in discretionary appropriations
- \$769 billion or 16% increase in non-defense spending
- 40% increase in funding high poverty schools & Title I grants
- 23% increase for Dept. of Health & Human Services, including Child Care Development Block Grant and Head Start
- Leaves out entitlement programs e.g. Medicare & Social Security
- Complementary to American Jobs Plan

### California's Fiscal Outlook: FY 2021-2022

- State economy has undergone rapid but uneven recovery
- Data on tax collection & public benefits expenditures consistent with positive economic picture
- Likely significant one-time budget windfall of \$26 billion
- State faces an operating deficit beginning 2021-22
- Budgets for schools and community colleges more positive
- Recommendations:
  - Restore Budget Resilience use half of windfall (\$13 billion)
  - Address One-Time Pandemic Needs
  - **Begin Multiyear Effort to Address Ongoing Deficit** 0





### **County Measure X Tax Revenue**



In November 2020, Contra Costa approved a sales tax increase of a half percent on all goods (excluding food and medicine). \$91 million in annual revenue with\$22 million in one-time funding toCounty General Fund

Funds regional hospital & community health centers, fire protection, safety net services, behavioral health, child care, homelessness & housing services



CAB has 95% share of advisory decision making, 5% will go to special interest bearing account.

## Equitable Economic Recovery

#### **Early Education**:

- Increased capacity for Head Start and Early Head Start (and related staff)
- Matching grants to community providers to allow for increased sliding scale spots for families

#### **Economic Development:**

• Technical assistance to very small businesses

#### **Workforce Development Board:**

• Technical assistance and support for companies to create paid internships
